
**CLASS-IV(Peon)**

- 4 Candidates whose names start with alphabet " H to J", will appear on **12.10.2017**;
- 5 Candidates whose names start with alphabet " K to L", will appear on **13.10.2017**;
- 6 Candidates whose names start with alphabet "M" , will appear on **16.10.2017**;
- 7 Candidates whose names start with alphabet "N to Q", will appear on **21.10.2017**;
- 8 Candidates, whose name start with alphabet "R", will appear on **23.10.2017**;
- 9 Candidates, whose name start with alphabet "S", will appear on **24.10.2017**


