

STATE ELECTION COMMISSION, PUNJAB.

NOTIFICATION The 3rd May, 2013

No. SEC-PE-SA-2013/701 .- In continuation of Commissions' Memo No. SEC-SA-2013/2097 dated 18.4.2013 vide which an advance copy of the Notification No. SEC-PE-SA-2013/698 dated 26th April, 2013 was sent to all Additional Deputy Commissioners (Dev.)-cum-Additional District Electoral Officers in the State for making necessary arrangements to hold the elections.

2. Now, therefore, in pursuance of the provisions contained in Section 35 of the Punjab State Election Commission Act, 1994 (Punjab Act No.19 of 1994) the State Election Commission, Punjab hereby appoints new dates for general elections to elect members of Panchayat Samitis and Zila Parishads in the State of Punjab with 3rd May, 2013 as the first day of filing nominations :-

PROGRAMME

- (a) 7th May, 2013 (Tuesday)
as the last date for making nominations;
- (b) 8th May, 2013 (Wednesday)
as the date for the Scrutiny of nominations;
- (c) 9th May, 2013 (Thursday)
as the last date for withdrawal of candidatures;
- (d) 19th May, 2013 (Sunday)
as the date on which a poll shall, if necessary be taken and;
- (e) 21st May, 2013 (Tuesday)
as the date on which Results will be declared.
- (f) 23rd May, 2013 (Thursday)
as the date by which the election shall be completed.

- Note: (1) 4th May, 2013 is not a holiday under Section 25 of the Negotiable Instruments Act, 1881, as such the nominations will be received on that day.
- (2) Counting of votes will start at 8.00 A.M. on 21st May, 2013.

In pursuance of the provisions of Section 57 of the Punjab State Election Commission Act, 1994 (Punjab Act No.19 of 1994), the Election Commission hereby fix poll hours from 8.00 AM to 4.00 PM during the poll on 19th May, 2013 to conduct the general elections of Panchayat Samitis and Zila Parishads.

With the issue of this notification on 3rd May, 2013 the Model Code of Conduct comes into effect immediately in villages falling in the poll areas within the revenue jurisdiction of the Panchayat Samitis and Zila Parishads and be operative till the completion of election.
